INTRODUCTION

EISAI MALAYSIA cares about your personal data protection. This notice clarifies how EISAI MALAYSIA (referred to as “we”, “us” and “our”) processes your data from the point we collect, use, share, dispose of and the security measures that we established to ensure your personal data is well protected in compliance with the Personal Data Protection Act 2010 and its regulations.

COLLECTION OF PERSONAL DATA

We have collected and collect your personal data to be processed by us in the course of your present or future dealings with us, our headquarters, our subsidiaries, our associates. The types of personal data which we collect include: your name, your practice specialty, place of practice, key details of our representatives’ interactions with you and the brands discussed.

SOURCES OF PERSONAL DATA COLLECTION

We gather your personal data from:

3. Consent forms

REASONS FOR PERSONAL DATA COLLECTION

We collect your personal data to:

1. process your request to monitor the interactions of our representatives with you.
2. update our CRM system.

If you do not provide us with personal data, we are unable to process personal data on your behalf, for the purposes stated herein, or effectively render our services you.

PROCESSING OF PERSONAL DATA

We will first process your personal data in Malaysia by entering the same into our customer relationship management system (CRM system).

Your personal data will also be transferred outside Malaysia to third party data processing centres located in other countries, including Japan and USA. We will ensure a comparable level of protection for your personal data should the information be processed or used outside Malaysia.

DISCLOSURE OF PERSONAL DATA

We may share your personal data to other entities within our group which will treat your personal data as confidential and process it in accordance with all applicable data protection legislation for the purposes and within the terms set out herein.

We will also disclose your personal data to:

1. Our CRM system

SECURITY MEASURES

We take these measures to protect your personal data:

1. by ensuring your personal data is kept as required by the Personal Data Protection Act 2010.
2. by ensuring our staff not to misuse your personal data.

We use computer systems with limited access housed in facilities using physical security measures. Data stored in cloud services is in encrypted form including when we utilize third-party storage. The level of security of personal data which kept in a non-electronic environment are also treated with strict procedures and means.

PERSONAL DATA RETENTION PERIOD

Retention of your personal data is required to effectively provide you relevant information of our products and services to you based on your area of practice. Retention is also required for our internal audit purposes (e.g., keeping records of the interactions with our sales representatives and our products).

We will retain your personal data for six (6) years. If you are no longer our customer or if you expressly instruct us to delete your personal data, we will permanently delete your personal data.

3. stop or limit our communication with you by emailing us below.
